Please fill out the following application and mail it to the address below. Your complete application packet should be postmarked no later than Friday, May 5, 2017. Incomplete or unsigned applications will not be considered for this scholarship award. The Scholarship Committee retains all rights of interpretation or clarification of the scholarship awarded to High School Graduates, Continuation of Education from an accredited college/university, Young Professional award, and President's Choice Award. All monies will be directly deposited into your member share account at Border Federal Credit Union.

Family members of Border Federal Credit Union employees, Board Members and Supervisory Committee are eligible to be considered for the scholarship award.
